SECTION 4: First aid measures

4.1. Description of first aid measures

Inhalation	If symptoms develop, remove affected person from source of exposure into fresh air. Get immediate medical attention.
Skin contact	Wash off with soap and water. Wash off with soap and plenty of water. Call a POISON CENTER or doctor/physician if you feel unwell. Get medical attention if symptoms occur. For minor skin contact, avoid spreading material on unaffected skin. Wash clothing separately before reuse.

Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Cover with plastic sheet to prevent spreading. Clean contaminated surface thoroughly. Absorb in vermiculite, dry sand or earth and place into containers. Following product recovery, flush area with water.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Never return spills in original containers for re-use. Clean up spills immediately, observing precautions in Protective Equipment section. Sweep up and shovel into suitable containers for disposal.
